Update from Clinical Lead

Welcome to the SCIMP newsletter for Spring 2018. At a time of huge change for general practice SCIMP are busier than ever working with colleagues across NSS and Scottish Government on programmes using eHealth in support of general practice.

Highlights include the GP2GP programme with SCIMP providing safety assurance and informatics support. GP2GP will help preserve the patient's lifelong GP record as they move between practices. Experience is positive so far, and we hope to see 'Vision to EMIS' and 'EMIS to Vision' working soon.

SPIRE is rolling out across Scotland and we are supporting the business analysts with clinical terminology expertise. SPIRE is a key tool to help clusters improve clinical care and we would like to make it easier for practices to record high quality data in support of this. Working with the SPIRE steering group we are proposing the establishment of a data quality stream to help achieve this. As part of this work we hope to be able to revise and renew the 'SCIMP 800' codeset which is used to assist in coding of records.

Spotlight SNOMED CT

SMOMED CT is the new terminology that has potential to support the whole of health and social care, not just General Practice.

SNOMED CT will replace Read Codes in GP systems in the next few years, with NHS England rolling out limited SNOMED CT this year. SCIMP have expertise in SNOMED CT as a clinical terminology to support NHS Scotland in due course.

Although SNOMED CT is more complicated that Read Codes, we hope that new clinical systems will make it easy for users to code correctly and hide much of the complexity.

Decision Support

We are pleased that the National Decision Support programme has picked Cambio Systems as its provider for decision support applications across NHS Scotland. This is a solution based on open standards and modern interoperability which should allow NHS Scotland to author and maintain its own decision support rules and applications. SCIMP are working with the programme lead to develop the initial decision support pilots for primary care, and to help to safely progress the technology to work with our current and future GP Systems.

The vision is to provide a national library of re-usable decision support applications for use across domains and systems in NHS Scotland.

SCIMP is presenting on the decision support programme at eHealth Week in London on May 15th / 16th

GDPR

The General Data Protection Regulation (GDPR) updates data protection law and comes into effect on 25th May 2018.

SCIMP provided advice to the short life working group on Information Sharing for Scottish Government.

The outcome of Joint Controllership of General Practitioners and Health Boards to meet GDPR requirements is hugely positive and should improve the way we manage data governance in general practice.

While there is still work to do it is great to see a substantive way forward.
