The 2009 SCIMP annual conference was held on 3rd & 4th November at the Doubletree Hilton Hotel, Dunblane and was attended by around 250 delegates and exhibitors from a varied range of Health Service professionals and suppliers.

H1N1 INFORMATION ON SCIMP WEBSITE

In conjunction with the Scottish Government Health Directorates, SCIMP have produced guidance for practices relating to IT issues that may present when dealing with the H1N1 Influenza pandemic. The document relating to immunisation has been updated to Version 4 (issued on 15.12.09) with additional information, particularly relating to pregnancy coding, issues with vaccine coding and allergies to the vaccine. These documents will be updated again as more information becomes available and as the software systems make further developments.

TEST PATIENTS

Test patients should never have a CHI number on the system as this could be transferred onto other databases such as SCI-DC and SCI Store and overwrite records belonging to an existing patient. There have been incidents where overwriting has affected whether patients routinely receive their retinopathy screening invitations.

UPDATES TO THE GPASS DATA PROTECTION SUMMARY (DPS)

Practices are required to send a summary of all clinical information when a patient moves to a new practice. Different systems have different methods of doing this but the current Gpass DPS is not user friendly for the new practice so a new Patient Transfer Summary has been developed. This summary will include all Palliative Care data, F3 Clinical Notes, F3 Adverse Reactions and Values. It is recommended that practices produce this transfer summary and include it in the Docman transfer when a patient transfers to another practice.
